Would your hall be interested in holding a Boxercise or Spinning Cycling Class?

Teesdale Leisure Services currently have funding and an instructor to provide a Boxercise class and a Spinning class within village halls in Teesdale. Boxercise is a fun stress busting workout and Spinning is an indoor group cycling exercise class. Both classes would be for those aged 16 +. The Boxercise class can be run for 40 weeks and would require at least ten people. The hire of the hall and tutor costs will be funded and attendees would be charged at £4.00 per session. It would be possible to arrange taster sessions in halls to see what local interest there would be. The Spinning class can run for 50 weeks and would also require at least ten people. Again, the hire of the hall and tutor costs will be funded and attendees would be charged at £4.00 per session. However with the spinning class, a large storage area would be needed for the bikes. Who can apply? Community groups working within County Durham (excluding Darlington)

How much is the award? The committee will consider awards up to £2,000

Criteria: Funding will be awarded to groups that can demonstrate the money will be used for projects that aim to

- Improve Physical Health
- Address Health Inequalities
- Improve Mental Health and Wellbeing
- Supporting Users and Carers with Long Term Conditions

Examples could be projects that aim to:

- Reduce Heart Disease
- Stop Smoking
- Provide Exercise and Positive Lifestyles Activities
- Improve Nutrition
- Improve Mental Health and Motivation

Durham County Council Arts Development Small Grants Scheme

This is a scheme to support projects which contribute to the creative and cultural development of County Durham. Applying for a small grant is one way in which groups can get involved in County Durham's bid to become UK City of Culture. The maximum you can apply for is £500.00. The next deadline for the 2009/10 round of the scheme is 12noon on 15th March 2010. You will be notified within two weeks of the outcome.

Who is eligible to apply? Community and voluntary organisations, arts organisations, social enterprises, parish or town councils, professional artists providing they can show that there is a wider community benefit as a result of funding. You must be based in County Durham and your project must benefit the people of County Durham.

Priorities for creative projects: The funding is to support creative projects which respond to Durham County Council's priorities which are to support:

- More people getting involved in arts activities
- Aspirations to achieve high artistic and creative quality
- Strengthening existing partnerships or building new ones
- Arts development – working across new art forms, learning new skills, reaching new audiences
- Meeting one or more council priorities – healthier communities, safer communities, people enjoying, achieving and making a positive contribution, economic wellbeing and an improved environment.

Grassroots Grants Funding – Update

The purpose of the Grassroots Grants is to support small, informal voluntary and community groups and organisations to develop their capacity and provide them with the ability to respond to their community's needs. The grants provided can support capital or revenue purchases; the minimum grant is £250, the maximum is £5000.

Funding is still available from this programme; however any awards made now will not be released until April 2010. Groups are encouraged to continue to submit applications which, as funding cannot be retrospective, should be for projects and capital or revenue costs for the financial year beginning 1st April 2010. These will be assessed and presented to the panel for decision. You will receive an offer letter if you have been awarded a grant but the funds will not be released until April 2010. Examples of what Grassroots will fund includes purchase of equipment e.g. oven, furniture; costs of putting on a local event or workshop; staff costs to enable the employment of individuals; contribution to rent costs (related to activities/service delivery); the cost of attending a conference or event; training for volunteers; additional activities to expand an existing funded project; activities that support community activity..

Government to End Rain Tax for Community Sector

The Government has signalled its intention to introduce new legislation that promises to end crippling water charge increases for community groups. The Flood and Water Management Bill will allow water and sewerage companies to apply concessionary schemes for community premises, thereby ending the financial difficulties faced by community organisations being charged according to the size of their site instead of their rateable value. The good news marks a turning point in the long campaign by the community sector to stop huge increases in water draining charges for community centres, village halls, churches, scout groups, sports clubs, youth clubs and other community organisations. Last year OFWAT decided to end the concessionary rate for charities, leaving the water companies free to charge community organisations commercial rates.

In a speech made to the Labour party conference Hilary Benn, Secretary of State for Environment, Food and Rural Affairs announced new legislation that would allow water companies to offer concessionary rates to community groups. Mr Benn said:

“Some churches, sports clubs and youth groups have been hit by huge increases in their water bills for surface drainage. It isn't right. So I can tell you today that we will legislate to allow water companies to run concessionary schemes for these organisations so they can get on with the great job they are doing instead of worrying about unaffordable bills.”

This information has been extracted from the October 2009 Community Matters magazine and the Consortium will keep you updated as we hear more on this issue.

Licensing Act 2003 Changes – Training Session

As reported in the TVHC September newsletter, changes to the Licensing Act 2003 took effect from 29th July 2009. The Legislative Reform (Supervision of Alcohol Sales in Church and Village Halls) Order 2009 allows volunteer committees managing community buildings to take joint responsibility for the sale of alcohol in their buildings instead of being required to appoint an individual as the Designated Premises Supervisor (DPS). Management committees will need to ensure that the sale of alcohol is included in their Premises Licence and be able to demonstrate clearly to their local licensing authority how they operate and that there will be appropriate supervision of alcohol sales at different types of events.

TVHC is looking at setting up a training session in the New Year which would be ran by Durham Rural Community Council for any halls that are interested in finding out more about the Order and what this will involve for your committee if you are to take advantage of it.

Barnard Castle Rotary Club 'Eradicate Polio Now' Mobile Phone Recycle Campaign

Barnard Castle Rotary Club has launched a trade used mobile phones campaign in order to raise funds to totally eradicate the dreadful disease of poliomyelitis. Although the UK is virtually free from this crippling disease thanks to NHS ant-polio jabs, it is still a big problem in Africa, India, Pakistan and Afghanistan. These countries do not have the resources or infrastructure to treat everyone.

Robert Hartness from Barnard Castle Rotary Club explains how people can help: "In a nutshell, we want all the residents to look around their homes and places of work for used mobile phones. We have set up a special website where anyone with a used mobile phone can go online and discover how much it is worth at www.endpolio.co.uk"

They have teamed up with Envirocharities Ltd to collect up as many phones as they can right throughout Teesdale. They are arranging for such phones to be collected; there are collection points around the Dale.

There has been a good response to the campaign so far. The Rotary Club are looking for local organisations to promote this campaign amongst their workforce. They also need 'drop off a mobile' locations where those who do not have access to the Internet can simply turn up and hand in a phone.

Teesdale Action Partnership – November 2009 Update

The following project proposals will go forward to appraisal for funding from the 2009/2010 budget. (Agreed via consensus of the Board):

The Broadband Priority Theme: contribution to extension of the Barnard Castle Vision Project to provide broadband for people in Teesdale.

The Support for Older People Priority Theme: a Teesdale Older People Support (TOPS) small grant pot for easy access to grants for activities and events; a dedicated slot in the local media for older people (Radio and newsletter/paper); and an Over 50s Healthy Living Project

The Environment and Street Scene Priority Theme: the toilets in central Barnard Castle, and community facilities in Eggleston,

Following appraisal, a recommendation on each proposal will come back to the Board. The Board then recommends approval before final approval from Durham County Council.

Playbuilder Programme: Part of National Play Strategy, the Programme is about encouraging managed risk, so the funding is not for swings and slides. Bids are being sought for another 10 Playbuilder sites across County Durham for 2010/2011. Each AAP can submit up to 3 proposals. Groups need to submit Expressions of Interest to the AAP Co-ordinator by 11th December 2009.

The next Teesdale Action Partnership board meeting will take place on Wednesday 13th January at 6.00pm at the Randolph Centre, Evenwood.

County Durham Handyperson Service

I have been notified by Age Concern that they no longer run the handy van service and if any halls still have any of the old leaflets provided by Age Concern please can you dispose of these. The service has been taken over by Three Rivers who provide a handyperson and minor adaptations service across County Durham. The service focuses on older and vulnerable people and will carry out small repairs and maintenance jobs within people's homes and their immediate external environment. It aims to promote independent living, reduce accidents within the home, improve quality of life and maintain a sense of well-being, safety and security for the residents of the County. The service covers the former districts of Teesdale, Derwentside, Durham and Chester-le-Street, Easington, Wear Valley and Sedgefield. To compliment the handyperson and minor adaptations service, they will also carry out home safety assessments, jobs to facilitate hospital discharge and the installation of sensory and telecare equipment. Proposed Single Tariff for PRS and PPL Licences

ACRE (Action with Communities in Rural England) is seeking feedback from village hall committees about a proposed new single tariff for PRS and PPL licences. Currently most halls would need a PRS licence (for the playing of recorded music) but not necessarily a PPL licence which is needed for the playing of records, CDs, DVDs etc. for commercial purposes because they are charities.

The PRS licence costs 1% of a halls income with a minimum of £40.00 per year but there is a proposal that the two licences can be combined at a fee of £81.00 per year to be applied irrespective of the fact that the organisation is charitable. Any hall with an annual income of less than £8,100 will therefore be worse off.

TVHC Criminal Record Bureau Checks Service

Teesdale Village Halls Consortium is offering a Criminal Records Bureau check service to voluntary and community organisations in Teesdale. Helen Thistlethwaite has been trained as an appointed person to assist those wanting to apply to have a CRB check carried out. People who work unsupervised with children or vulnerable adults should have a CRB check carried out. TVHC can assist with completing a disclosure application form and carry out a check on the required identification documents.

The Consortium is offering this service in conjunction with CAVOS (Community and Voluntary Organisations Sedgefield) who are a registered body with the CRB. TVHC wants to provide this service locally to make the process as simple as possible for voluntary and community organisations in Teesdale.
